## **AIS Update**

In spite of all of our efforts to protect lakes Sallie and Melissa from getting an infestation of zebra mussels, some of the mussels have been found in Lake Melissa.

The State of Minnesota has appropriated money to help counties control Aquatic Invasive Species and Becker County received over \$150,000 the first year with an additional amount of \$319,000 for 2015. The county is working on a plan to distribute these funds. The County did purchase a Hydro Blaster decontamination unit which will be available for use by all boat owners in Becker County. The machine will be located in Detroit Lakes because they have localities where it can be stored and have the water supply needed to operate the machine. We will send out a notice when we know where the machine will be this Spring. The County Commissioners are also considering the purchase of an additional AIS decontamination unit for this season.

Becker County has begun the recruitment of AIS Inspectors for the 2015 season. Along with recruitment of these paid positions, the Sheriff's department will again assign additional deputies for AIS Inspectors and education. It is very important that we have enough inspectors on Sallie and Melissa. All boats leaving Melissa will need to be inspected and we want to do all we can to stop the spread to Sallie. Those interested in the positions, which will pay between \$12 and \$15 per hour, should contact the Becker County Human Resources Department.

There has been some progress in finding a solution to the zebra mussel problem. Christmas Lake near Minneapolis has been treated with Zequanox and potash and the initial results are encouraging. The area treated was very small and it will be some time before we will know if it was totally successful and can be used in other lakes. But it is encouraging and we are hopeful that we will be able to control this species before too long.

# DNR postpones AIS training and trailer decal program

The Minnesota Department of Natural Resources will postpone the new aquatic invasive species training and trailer decal program that was due to launch at the end of the month while legislators consider changes to the program.

Under a law passed by the state Legislature in 2012, anyone trailering a boat or water-related equipment such as docks and lifts in Minnesota is required to take aquatic invasive species training and display a decal on their trailer. The effective date is July 1, 2015.

"With the legislative interest in this educational program and ongoing discussions about possible changes, we are postponing the launch until we see if the Legislature acts this session to modify the program," said Bob Meier, DNR assistant commissioner.

The DNR supports the education that would be provided under this law, but recognizes there are some concerns with the way the law is currently written. For example, people transporting boats on trailers through Minnesota to another destination are required to take the course and display a decal even if they don't put their boat in Minnesota waters.

Since the training and decal are currently not required until July 1, the DNR wants to remind people that there will be time to see what happens legislatively and still take the course and receive decals. The agency will post any updates on trailers at <a href="https://www.trailers.mndnr.gov">www.trailers.mndnr.gov</a> and alert the media if there are any program changes.

## **Ice Ridges**

With the warm winter and small amount of snow cover, the lake ice is really moving this year. There are many areas around the lakes where the ice is pushing sand up onto properties.

According to the DNR website: What are the benefits of ice ridges? Ice ridges are natural berms that have formed around Minnesota's lakes over thousands of years. These mounds of material provide the lake with ecological benefits by creating a barrier to nutrient loading. Nutrients collect on the landward side of the mound, producing fertile soil where plants and trees thrive. The root systems of this near-shore plant community help to protect the shore from erosion and soak up additional nutrients. Shade and habitat offered by near-shore plants benefit organisms along the shore and in the lake, thus supporting nesting and spawning fish. Ice ridges also work to protect the shore from the lake itself. For example, a small ice ridge formed one year is followed by additional pushes in ensuing years. The ridge is fortified by jamming rocks into it. The roots of the near-shore plant community bind together the soil and rock to form natural shoreline protection. ©2003 State of Minnesota, Department of Natural Resources.

So, although the ice ridges protect the lake from nutrient loading, you may need to do some work this spring to get access to your docks! The Pelican River Watershed District <u>does</u> require a permit to repair damage to the shoreline.

If you plan to undertake any land alterations within PRWD's Shore Impact Zone, your project is subject to permitting. This includes the following activities:

- Rip-rap installation
- Brush or tree removal
- Ice ridge leveling or repair
- Sand blanket installation

Frozen pipes bursting onto the local scene-DL newspaper online

It's been a tough winter for septic system experts, even though warm weather would dictate otherwise. "We're seeing a lot of frozen tanks," said Dave Hacker of Backhoe Pete. (continued from previous column)

Warm weather drives the frost down and the frost gets down around the pipe if people don't use enough water. Hacker said families with kids who frequently shower and do laundry aren't in much danger of freezing. But weekend residents have been calling for help with burst sewer lines that have to be steamed out and frozen septic tanks.

"We're seeing more freeze-up," he said. The biggest reason is lack of snow for insulation. Hacker said many people throw hay bales over their tanks but then leave them exposed to the elements. Wet straw is the worst type of insulation, he said. It provides no insulation unless you cover it with a tarp to keep it dry. Wet insulation keeps the ground frozen in the spring, he said, prolonging the need for a professional to help thaw lines.

He's seeing lift stations freeze up worst. And he said he's not allergic to doling out professional advice for homeowners to help themselves. A heater on a list station can easily be installed by a homeowner, once they have the know-how, which a professional can give. He doesn't advise installing your own heater system until you've talked to a professional about the brand and installation methods.

"You can still have problems with daily water use," he said. A leaking toilet or a drippy faucet can fill a septic tank and freeze if not attended to. Hacker said at night, he runs his faucets 20 minutes before bedtime, because shallow pipes can still freeze overnight.

Three to five gallons down the water line can help flush them clean. "I've found frost down four-and-a-half-feet deep," he said, which may surprise people who think we've had an abnormally warm winter. "I've seen a lot of septics with frost in the tank or ice forming on top of the tank. Luckily we've caught it them all in time."
